Strategic Planning - the Path Forward

Prospectus Berco's mission is to provide innovative community participation, community living, employment opportunities, and support services that enrich the lives of people with disabilities and their families.

Among the many projects Prospectus Berco's team is addressing, updating our strategic plan was prioritized this spring. A Strategic Planning Task Force comprised of three Board Directors and 11 key staff from day services, residential services, and administration met for three, half-day sessions to plan for the future in response to several immediate areas of importance: staffing challenges, community integrated and employment-first program expectations, and succession planning due to the retirement of leadership staff. Working with facilitators Marilyn Marles and Dr. Andrew Cook, we were skillfully guided through the process of reacting to a comprehensive strengths, weaknesses, opportunities, and threats (SWOT) assessment to identify five critical issues facing the

corporation. They are culture, staffing, programs, financial health, and succession. The Task Force also agreed that embracing innovation throughout each of the five goals established to address these critical issues was important.

The sessions were energizing and inspiring as each individual's voice and wisdom were freely expressed and valued. Of specific note was the shared vision for Prospectus Berco's path forward that the group ultimately designed. The group collaborated on a mission refresh which yielded a final statement that incorporates the focus of community-based services. Our new mission statement is "Prospectus Berco provides innovative community participation, community living, employment opportunities, and family support services that

enrich the lives of people with disabilities and their families." We will fulfill our mission by engaging and supporting a talented and compassionate workforce; being inclusive; and living the guiding principles of accountability, communication, and trust every day. It is the vision of Prospectus Berco that in fulfilling our mission, we will be "Building an inclusive community where every person can live the life of their choice."

Professional Development

National Alliance of Direct Support Professionals - the path forward

With funds received by the Office of Developmental Programs (ODP), Prospectus Berco will implement two initiatives to enhance the quality of its services for the individuals it serves by offering professional development and credentialing for frontline workers. The first initiative addresses our need to expand our medical care team. Since efforts to hire qualified nursing staff have been unsuccessful, the administration identified three long-time employees to enroll in local LPN programs. Currently, two of the individuals are pursuing this educational opportunity. Prospectus Berco will fund the education of these individuals who will then become members of our medical care team.

The second initiative is through membership with the National Alliance of Direct Support Professionals (NADSP), which will enable frontline workers to enroll in the E-Badge Academy, a credentialling program for caregivers in the human services field. "NADSP Membership is a promise by organizations to direct support professionals, that they truly understand and genuinely value the contributions of the workforce," says Joseph Macbeth, President and Chief Executive Officer of NADSP. "As a result of this support, we'll be able to work together to improve practice standards, promote

system reform, and advance the knowledge, skills, and values of DSPs."

"For many years we wanted to join NADSP to elevate the position of our DSPs," said Kimberly Alarcon, Human Resources Administrator. "Through the credentialling program, DSPs will be stronger advocates for individuals with disabilities and will receive recognition for the skills they have worked hard to acquire," she said. While Prospectus Berco will pay for the credentialling, the program is voluntary for any DSP and frontline manager who wishes to enroll in the E-Badge Academy. It is our hope that after achieving the DSP 1 level, caregivers will continue to work their way through the E-Badge Academy to further develop their skills and professional development in specific areas of interest, like behavioral health and dietary meal planning.
