



PROSPECTUS BERCO

TEMPORARY VISITORS POLICEY FOR COMMUNITY HOMES (Effective Immediately and until further notice)

To maintain the health and safety of our program participants and employees, Prospectus Berco is following protocols for visitation to Community Homes:

Visitation may resume for Community Homes; however, arrangements need to be made in advance with the Residential On-site Manager to schedule their visit.

Visitors will be required to follow corporate protocols during their visit:

- No more than two people may visit at one time.
- Visitors will be contacted within one hour prior to their visit to complete a pre-health screening questionnaire.
- Before entering the home, visitors will have their temperature taken
- Visitors will be expected to wear full Personal Protective Equipment (PPE), including KN95/N95 mask, face shield, gown and gloves. If visitors do not have the required PPE, a PPE Kit can be purchased in advance by contacting Brooke Wagner, RN, Day Services Health Coordinator at 610-372-4737, ext. 703. The cost is \$15.
- If possible, visits should be held outside or in a designated room away from others.
- Eating and drinking on the premises will be prohibited because that would require visitors to remove their mask.
- Visitors who wish to take a program participant out of the Community Home for travel out of the state, should know that in compliance with the Pennsylvania Department of Health, program participants will have to self-quarantine for 14 days with no COVID-19 symptoms before returning to the Community Home. TEMPORARY VISITORS POLICY FOR FAMILIES

ON SITE VISITS:

- PRE-SCREENING (NO MORE THEN ONE HOUR BEFORE THE VISIT)
- TEMPERATURE WILL BE TAKEN BEFORE ENTERING THE HOUSE
- WASH HANDS ONCE ENTERED AND PUT ON GLOVES
- NO MORE THEN 2 VISITORS AT ANYONE TIME
- PERSONAL PROTECTIVE EQUIPMENT (PPE) MUST BE WORN DURING THE ENTIRE VISIT
 - KN95 OR N95, FACE SHIELD, GOWN AND GLOVES
- NO EATING OR DRINKING ON THE PREMISES
- IF POSSIBLE, VISITS SHOULD TAKE PLACE IN A DESIGNATED AREA AWAY FROM OTHERS, OUTSIDE WEATHER PERMITTING

TRAVEL:

- ANY TRAVEL OUT OF STATE WILL REQUIRE 14 DAY QUARANTINE WITH NO COVID-19 SYMPTOMS FOR THE PERSON OR THEIR TRAVELING COMPANIONS PRIOR TO RETURNING TO THE COMMUNITY HOME

PERSONNEL PROTECTIVE EQUIPMENT:

- MAY BE PURCHASED AT PROSPECTUS BERCO KUTZTOWN ROAD FACILITY FOR A COST OF \$15.
